**GUESTS:** Denise Ayer-Phillips of the Santa Rosa Welcome Center/Visit Santa Rosa introduced herself and said that she and her staff have produced an updated map of all the Peanuts character statues located throughout Santa Rosa. Since becoming manager of the Visit Santa Rosa Welcome Center there have overwhelming requests for an updated map for Peanuts Statues. After checking with Charles M. Schulz Museum they decided to produce the map on their own, which took 7 months. Along with the map they produced a flyer with a QR that holds all the information, a window sticker and facts on the statues all free of charge. Denise is now visiting various businesses that have these statues and gained unbelievable amount of interest and information on the statues. These are works of art that originated in 2005 and with years come change, so some of the statues have new homes and some are in need of care. Denise also, reminded the Board of Directors that the Santa Rosa Welcome Center is now the doorway to Santa Rosa/Railroad Square, because of the Smart Train, so she would like to get more updated Historic Railroad Square Association brochures to pass out to visitors at the Welcome Center.
